CALL TO ORDER

The meeting was called to order at 6:30 p.m. Motion was made by Mrs. DeLauter, seconded by Mr. Mayo, to move into executive session to discuss personnel matters. Motion was carried 4-0. The meeting reconvened at 7:39 p.m. Mr. Schissler led those present in the Pledge of Allegiance.

Mrs. Lanci called for a moment of silence in memory of Mrs. Testa's mother who passed away last week.

APPROVAL OF MINUTES
