CALL TO ORDER	ON A MOTION by Mrs. Cmar-Grote, seconded by Mrs. Lanci, and carried 4-0, the meeting was called to order at 5:08 p.m.
PLEDGE OF ALLEGIANCE	Mrs. Lanci led those present in the Pledge of Allegiance.
MISSION STATEMENT	Mrs. Malloy read the District’s Mission Statement.
EMERGENCY RESOLUTION	4.0 ON A MOTION by Mrs. Lanci, seconded by Mrs. Malloy, and carried 4-0, the Board of Education approved the emergency resolution stated herein. <i>Mr. Nardo arrived after the Motion at 5:10 p.m.</i>

WHEREAS, the North Bellmore Union Free School District discovered that the fire alarm and safety systems in the buildings are in need of repair and/or are otherwise not functioning properly;

WHEREAS, inspection of the fire alarm and safety system district-wide revealed that various components of the fire alarm and safety systems require repair in order to adequately protect the property and its occupants;

WHEREAS, such condition requires immediate action including repair and/or replacement of the components of the district-wide fire alarm and safety systems including fire doors, and emergency exit lights in order to

preserve the health, safety and welfare of the students, staff and residents on the property and to preserve the integrity of the property; and

WHEREAS, the School District is under fire watch as an interim safety measure.

NOW THEREFORE, BE IT RESOLVED that the Board of Education of the North Bellmore Union Free School District hereby declares the above-referenced condition to be an emergency; and

BE IT FURTHER RESOLVED that the Board of Education authorizes the repair and replacement of the above-described condition on the School District property as an ordinary contingent expense of the Board of Education and authorizes the Superintendent of Schools or her designee to take the necessary legal steps to correct said condition.

ADJOURNMENT
