### MINUTES OF THE NORTH BELLMORE UNION FREE SCHOOL DISTRICT BOARD OF EDUCATION MEETING June 7, 2018

The regular meeting of the North Bellmore Union Free School District Board of Education was held on Thursday evening, June 7, 2018, in the All Purpose Room of the Martin Avenue School at 2616 Martin Avenue, Bellmore, New York.

#### **CALL TO ORDER**

The meeting was called to order at 6:50 p.m. Motion was made by Mr. Ferrara, seconded by Mrs. Cmar-Grote, to move into executive session to discuss personnel matters. Motion was carried 5-0. The meeting reconvened at 7:40 p.m. Mr. Mayo led those present in the Pledge of Allegiance. Mrs. Lanci then read the District's Mission Statement.

## APPROVAL OF MINUTES

Mrs. Lanci moved that the Board of Education approve the Minutes from the Regular meeting of May 8, 2018 and Minutes from the Special meetings of April 26, May 15 and May 22, 2018. Mrs. DeLauter seconded, and the motion was carried 5-0.

### SPECIAL PRESENTATIONS

#### **BUDGET**

Mrs. Testa provided a brief overview of the budget revote, which will be held on June 19 at Newbridge Road School from 6 AM to 9 PM. Mrs. Testa explained that the budget failed because it did not get the 60 percent pass rate that was required. The revised proposed budget contains an additional \$75,000 in reductions due to a reduction in expenditures related to the district's insurance cost and BOCES rental fees. The revised budget carries a 3.20 percent tax levy increase and stays within the district's allowable property tax levy cap. Mrs. Testa added that there are no additional propositions on the June 19 ballot. The revised proposed budget needs a simple majority (50 percent +1) for approval.

#### **BUDGET**

Mrs. Testa indicated that if the budget is defeated a second time, the district must adopt a contingency budget and the proposed budget would be further reduced by an additional \$1.2 million resulting in deep cuts in personal, including the elimination of teachers and staff. Mrs. Testa added that it could take seven years to reinstate programs once eliminated due to a contingency budget.

#### SUPERINTENDENT'S REPORT

Mrs. Testa stated the district will host a press conference with Sen. Brooks tomorrow at Newbridge Road School where the Senator will announce his plan to introduce a Property Tax Relief Bill that would change the rules by which districts receive state aid and could bring property tax relief to Long Islanders. Mrs. Testa invited the community to attend. The legislation would increase financial support from the state in districts in which at least half of the annual tax levy is paid for by the residential property owners. After the 50 percent cap on the residential tax burden, the state would pick up the difference. In North Bellmore, where there is only a small commercial tax base, approximately 70 percent of the educational tax is paid for by homeowners. Mrs. Testa stated that she has been advocating for reform for many years for districts, which have a large residential property tax burden and was grateful to Sen. Brooks for introducing legislation to address it.

Mr. Mayo encouraged the community to cast their vote on June 19

# EAGLE SCOUT PROJECT

Mrs. Testa introduced former Martin Avenue student and Boy Scout John Berry who presented his Eagle Scout project to the Board of Education to build a Buddy Bench for the students of Martin Avenue School.

Mrs. Lanci moved that the Board of Education approve the Eagle Scout Project. Mr. Ferrara seconded and the motion was carried 5-0.

### ART STUDENTS RECOGNITION

Mrs. Testa stated that we are celebrating the art students tonight. She added that their artwork will be proudly displayed throughout the district office hallways for everyone to appreciate. Mrs. Testa turned the meeting over to Mrs. Skelos who coordinates the art program. Mrs. Skelos thanked all, especially the students for their beautiful artwork. She then introduced the art teachers, Mrs. Skelly, Mrs. Lopez, Ms. Emmer and Mrs. Hill. Each teacher introduced and presented certificates to over twenty students whose artwork was on display. Mr. Mayo thanked all the students and called for a short break at 8:10 PM. The meeting reconvened at 8:27 PM.
