#### **CALL TO ORDER**

The meeting was called to order at 6:30 p.m. Motion was made by Mrs. DeLauter, seconded by Mr. Mayo, to move into executive session to discuss personnel matters. Motion was carried 5-0. The meeting reconvened at 7:44 p.m. Mr. Schissler led those present in the Pledge of Allegiance. Mrs. Cmar-Grote then read the District's Mission Statement.

# TREASURER'S REPORT

# BOARD COMMITTEE REPORTS/HIGH SCHOOL REPORTS

Mrs. DeLauter reported that the Board of Education recognized the Nassau County and Long Island Champions – Calhoun Boys Soccer and Nassau County Champions – Kennedy Boys Volleyball. Mepham student representatives spoke about their first motivational TEDx event. The Board approved Bond Referendum Projects Construction Change Orders.

#### **FINANCE**

The Board of Education acknowledged the review of the warrants that have been approved by the Claims Auditor for the month of November 2016.

Mrs. DeLauter moved that the Board of Education approve the budgetary transfers dated December 12, 2016. Mr. Mayo seconded and the motion was carried 5-0.

# SUPERINTENDENT'S REPORT

Mrs. Testa thanked the teachers for taking the time to find opportunities to integrate more physical activity during the school day by implementing movement breaks, brain activities, yoga, breathing exercises and dance routines in the classroom. Mrs. Testa quoted neuroscience research regarding movement breaks. She reported that research based movement breaks, such as activities being implemented in our district, support brain health and higher levels of brain function and cognition.

### Facilities update:

- Mrs. Testa stated that the district is continuing with lead testing.
- The Park Avenue announcement system will be replaced the first week in January.
- Over the holiday break, we are working on adding alarm capabilities to the exterior doors of the buildings.
- The traffic circle in front of Saw Mill Road School was repaved this week.
- As a following up to the special board meeting last month regarding safety and security, we are working with Summit Security to insure that the security guards understand our district protocols. Mrs. Testa thanked the principals for strictly enforcing the procedures.
- We are assessing the results of a lock down drill that was held this week. We will invite a representative from the police department in the future to come in for a drill.
- We are continuing to increase the LED lighting around the district buildings.

# Human Resources update:

• There is a shortage of substitute teachers due to the number of teachers retiring and a smaller amount of people coming into the profession. The State is making changes to the certification requirements to get more people to come into the field.

## Library update:

• Mrs. Testa thanked Mr. Rubio for submitting a proposal to the district for temporary housing for the North Bellmore Library. Mr. Schissler will meet with the Library to share the proposal.

#### Curriculum update:

- The Math Leaders met today to discuss professional development.
- Schoolwide Writing professional development is continuing throughout the year.
- Mrs. McNamara and the Literacy Coaches will be presenting a Writing Workshop Parent University on January 19.
- The K-6 narrative writing sample will be sent home in January.
- Mrs. Malone, Mrs. McNamara and Mr. Fischetti are working on our STEM initiative. Our technology teacher, Mr. Bevilacqua, will be facilitating a series of three Cubelets lessons in each Grade 4 class across the district.

#### **Business Office update:**

• The budget process is up and running. We are working on a draft budget. We are waiting to receive the Tax Cap information in January.
