BOARD COMMITTEE / HIGH SCHOOL REPORTS	Mrs. Lanci reported that the BMCHSD met last week on Wednesday, March 6. The BOE honored Ms. Zannino and Ms. Schlieth, recipients of the Harvard Club of Long Island Distinguished Teacher Award. Mrs. Lanci spoke of the rigorous process whereby Harvard alumni interview Harvard applicants among the Long Island senior classes to find middle or high school teachers who were inspirational in their lives. Following in celebration, she announced the BOE honored the Mephram Science Research Department on their scientific program and their success with the Regeneron Scholars. Mrs. Lanci reported Curriculum Instruction and Data held a presentation of the Middle School Advisory Program demonstrating the benefits afforded the students. She reminded all of St. Baldrick's at Mephram HS on March 20, and the upcoming BOE meeting in April.

SUPERINTENDENT'S REPORT	<p>Mrs. Testa informed the BOE and all those present this evening that the Superintendent's Report and the Business Department will be combined this evening for the Budget Presentation. Before moving forward, she expressed the following sentiments.</p> <p>Mrs. Testa, in celebration of the Newbridge Road School leaders and seeing in the audience many members of the NBTA from Newbridge, extended a heartfelt thank you on behalf of the BOE and herself for their amazing job performed during the lockdown. She spoke of recognition by the Nassau County Police Department and the Superintendents' Council, and commended them personally on their leadership and professionalism while following all the protocols of the safety drills practiced and supporting each other to keep everyone safe. Mrs. Testa reminded all that Newbridge has <i>HEART</i>, and reiterated her solemn gratitude.</p> <p>Finally, Mrs. Testa congratulated and extended words of praise and gratitude to Mrs. Pollitt, Ms. McNamara, the administrative staff, and all those who partook in the Professional Development Day to make it an amazing success.</p>

BUSINESS DEPARTMENT REPORT

Mrs. Testa and Mrs. Rehak presented a detailed power point presentation of the proposed 2024/25 budget, a copy which is available on the website for viewing. Mrs. Testa described the budget as a financial story depicting the goals of the district and the community for the future of education.

Mrs. Testa began by presenting an overview of academic studies, services, and programs available. She proudly spoke of continued advancements keeping up with next generation learning in literacy, reading and writing workshops, mathematics, science, social studies, the phenomenal special programs, i.e. art, music, physical education, library, Spanish instruction in Grade 4-6 with World Language experiences offered for grades 5-6 after school, and in the area of computer science, the continuous growth and upgrades in programs and equipment maintaining an alignment with the high school district. Mrs. Testa described ongoing Professional Development, i.e. trainings, workshops, and conferences offered for faculty and staff for continued growth in education on innovative learning techniques, and in the area of network enhancements, upgrades in building and network security.

Mrs. Rehak continued by addressing the budgetary goals of the district including supporting existing/new programs for the students of North Bellmore, improving and maintaining the district's buildings/grounds, safety and security, technology advancements, planning with long term goals in mind and continuing to look for outside revenue sources while striving to keep the tax levy within the tax cap to meet these goals now and in the future.

She detailed the breakdown of the budgetary components as follows:

- 10.22% - Administration
- 13.49% - Capital
- 76.29% - Programs

Mrs. Rehak indicated the proposed tax levy is estimated at 2.39 percent with a budget-to-budget increase of 6.22 percent citing rising costs in benefits (health), transportation, insurance, increased professional development for new/existing program expansion, and budgetary capital projects including the electrical upgrade work at John G. Dinkelmeyer, Park Avenue, and Jacob Gunther (the other buildings were include in the 2023/24 budget) and brick pointing at Newbridge Road and Jacob Gunther schools.

Lastly, Mrs. Rehak spoke to a second proposition that will be on the ballot this year and stressed it does not add to the tax levy. Proposition 2 is seeking voter approval to expend money for *Phase 3* of the ceiling and pavement replacement at Newbridge Road and Jacob Gunther schools with an estimated start and completion date summer of 2025.

WHEREAS, said capital improvements are subject to classification under the State Environmental Quality Review Act (SEQRA); and

WHEREAS, maintenance or repair involving no substantial changes in an existing structure or facility are classified as Type II Actions under the current Department of Environmental Conservation SEQR Regulations (Section 6 NYCRR 617.5 (c)(1)); and

WHEREAS, replacement, rehabilitation or reconstruction of a structure or a facility, in kind, on the same site, including upgrading buildings to meet building or fire codes, unless such action meets or exceeds any of the thresholds in section 617.4 are classified as Type II Actions under the current Department of Environmental Conservation SEQR Regulations (Section 6 NYCRR 617.5 (c)(2)); and

WHEREAS, routine activities of educational institutions, including expansion of existing facilities by less than 10,000 square feet of gross floor area and school closings, but not changes in use related to such closings are classified as Type II Actions under the current Department of Environmental Conservation SEQR Regulations (Section 6 NYCRR 617.5(c)(10));

WHEREAS, the SEQR Regulations declare Type II Actions to be actions that have no significant impact on the environment and require no further review under SEQR; and

WHEREAS, the Board of Education, as the only involved agency, has examined all information related to the capital improvement projects and has determined that the Projects are classified as Type II Actions pursuant to Section 617.5(c)(1), (2) and (10) of the SEQR Regulations;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education hereby declares itself lead agency in connection with the requirements of the State Environmental Quality Review Act; and

BE IT FURTHER RESOLVED, that the Board of Education hereby declares that the Projects are Type II Actions, which require no further review under SEQR; and

BE IT FURTHER RESOLVED, that the Board of Education hereby shall forward an official copy of this Resolution to the New York State Education Department together with a copy of the correspondence from the New York State Office of Parks, Recreation and Historic Preservation in connection with its request for approval of the listed project from the New York State Education Department.

OLD BUSINESS

There was no old business discussed.

PUBLIC COMMENTS

Guidelines for Public Comments was communicated by Mrs. Lanci on behalf of the Board of Education.

Mrs. Karim (Old Britton Road) – *Ramadan cookies from the Karim family and Eid-al-Adha discussion*. Mrs. Karim presented the BOE with Ramadan cookies. She tabled her discussion of Eid-al Adha as the BOE this evening approved June 6, 2025, as a Professional Development Day in North Bellmore, and she expressed gratitude to the BOE on their decision. Mrs. Testa offered her appreciation to Mrs. Karim and other Muslim community members for their input and detailed information provided over the past year, and reiterated gratitude to the BOE for their time and consideration in reaching their determination.

Mr. Kushnir (*North Pierce Avenue*) – *Proposition 15.11* – Mr. Kushnir inquired if the expenditure this coming year is part of a previous estimate that has received increases (interest); he inquired with respect to the electrical upgrades, ceiling work, and other work, are there any energy efficiency rebates the district can take advantage of; and, as to the Project Management contractor, do they handle what's called additional costs that come in with respect to the expenditures. Mrs. Testa interrupted to clarify if Mr. Kushnir was speaking about soft costs, if we budget for that, and he replied in the affirmative. Mrs. Rehak responded that the district works directly with the architect and the project managers, and the initial costs came from the Building Condition Survey when all the buildings were evaluated. She explained each year, before the propositions are set, she meets with the Architect and the Project Managers to discuss how much to adjust those costs based on market changes and inflation. She indicated the plus interest has to do with the reserve. The reserve funds do earn interest and the interest has to go directly to the reserve as the funds do not transfer until the end of the year. Mr. Kushnir thanked Mrs. Rehak for her explanation.

Mrs. Lanci inquired if we have had energy performance projects here in the past. Mrs. Rehak responded affirmatively and indicated that is the debt service rolling off now. She explained one of the goals was to incorporate capital projects into the budget as debt rolled off so as not to increase the tax levy while still maintaining the cap.
