The Business meeting of the North Bellmore Union Free School District Board of Education was held on Thursday evening, March 13, 2025, in the All Purpose Room of the Martin Avenue School at 2616 Martin Avenue, North Bellmore, New York.

CALL TO ORDER The meeting was called to order at 6:30 p.m. A motion was made by Mrs. Corless,

seconded by Mrs. Malloy to move into an executive session. Motion was carried

MISSION STATEMENT Mr. Cunningham read the District's Mission Statement.

SPECIAL PRESENTATIONS: Music in Our Schools Month

Mrs. Testa, in honor of Music in Our Schools Month, welcomed faculty, staff, and families, and invited Mr. Madden, Assistant Principal at Saw Mill Road School and Music Liaison for the District with the support of Mrs. Brugge, Principal at John G. Dinkelmeyer, to open the festivities this evening. Mr. Madden thanked the BOE and Mrs. Testa for their invitation this evening and proudly shared in celebration of the arts the North Bellmore Festival Band to showcase their musical talent. Mr. Madden spoke of North Bellmore's dedication to inspiring students to be passionate

learners, meeting new challenges, and expressed gratitude to the BOE for their support of the arts and for recognizing the value of it in student development.

STAFF DEVELOPMENT

ON A MOTION made by Mrs. Malloy, seconded by Mrs. Corless, and carried 5-0, the Board of Education approved the Staff Development Report dated March 13, 2025 (on file at District Office.)

SUPERINTENDENT'S REPORT

Mrs. Testa happily announced the appointment of Rose Scammell to the position of Director of Special Education and Student Support Services, welcomed her to the North Bellmore community and introduced her to all present this evening. She proudly spoke of Mrs. Scammel's outstanding qualities and devotion to special elementary education, and shared excitement for Mrs. Scammel's arrival into the District on April 22. Mrs. Testa expressed gratitude to all that participated in the rigorous selection process and recognized and extended gratitude to Mr. Howard Bernstein for his dedication and service as the interim.

Mrs. Lanci on behalf of the BOE welcomed Ms. Scammel, and shared Mrs. Scammel's history as an alumna of North Bellmore, and extended gratitude to all the Committee members who participated in the hiring process.

BUSINESS DEPARTMENT REPORT

Mr. Cunningham presented a detailed power point presentation of the proposed budget for 2025/26 school year and indicated a copy will be available on the website for review. He addressed the core values/mission of the district in relation to the budgetary goals and highlighted the areas of focus including continued growth in Curriculum and Instruction, promoting new and existing program expansion through professional development, safety and security, supporting existing Special Area Programs, i.e., library, computer science, language, music, art, etc., and technology and network enhancements.

Mr. Cunningham detailed a breakdown of the budgetary components:

- 76.17% Programs
- 10.59% Administration
- 13.24% Capital Projects

He shared the budget contains a proposed tax levy increase of 2.55 percent and a budget-to-budget increase of 2.46 percent citing rising costs in transportation, special education, insurance, and professional development. Included also in Proposition I are budgetary capital projects districtwide, i.e. air conditioning and associated electrical upgrades, stage curtain replacement, select floor replacement, playground repairs, in addition to masonry type work at Newbridge.

Moving on, Mr. Cunningham spoke of Proposition II seeking voter approval to expend from Capital Fund 2022 for the reconstruction of select restrooms districtwide with no increase to tax levy. If approved, he detailed the process moving forward with a projected start date in the summer of 2026.
