The sixth-grade representatives prepared a slideshow and presentation to share and illustrate why Newbridge Road is special in their eyes. Starting with the HEART of Newbridge (honesty, empathy, acceptance, respect, and teamwork), they demonstrated through photos and words a positive environment modeled through the kindness of the Principal, Mrs. Licci, the faculty, and staff, various clubs and assemblies, i.e. Spirit Club, Smile, Café Group, to name a few, and intramurals, to facilitate learning and socialization through play, fun group activities, and field trips. The BMCHS met last week on Wednesday evening, December 3. Mrs. Lanci shared the BOE proudly honored Makayla Bowman, a senior at Kennedy High School, selected as a 2026 Coca-Cola Scholar Semifinalist, and Brad Seidman, a teacher also from Kennedy High School, was celebrated as one of the recipients of the 2025 Long Island High School Hero Award. In addition to items in the regular course of business, Mrs. Lanci happily reminded all to check the schedule of upcoming holiday events and concerts at the Middle and High School levels this month. The next BOE meeting will be held on January 7.

SUPERINTENDENT'S REPORT

Mrs. Testa was excited to share the holiday concerts have begun in North Bellmore, congratulated the faculty staff and students on the magical feelings illustrated through the musical programs produced, and extended gratitude to the BOE for listening and supporting ideas and events such as these in the community. Speaking of the holiday spirit, Mrs. Testa reminded all of the upcoming annual Polar Express fundraiser and extended her thanks and appreciation to Mrs. Lanci who runs and oversees this event each year in the North Bellmore community and other Long Island districts in support of families and students in need. Mrs. Testa verbalized her pride as a leader of a district in a community built on kindness, empathy, and collaboration of spirit.

Moving forward, on a sad note, Mrs. Testa shared that the Bellmore-Merrick Child Care Program, who have serviced the North Bellmore community since the 1970's, will effective the end of the 2025/26 school year, terminate their program in the North Bellmore School District community. Mrs. Testa spoke to her surprise, disappointment, and sadness upon hearing the news shared by Mrs. Smith, the Director of the program. Knowing the importance of the program to the community, she indicated Mrs. Pollitt and herself will be investigating options for families and students. Mrs. Testa informed the BOE that a letter will be sent out to the North Bellmore community sharing this news tomorrow and will keep them apprised of their efforts moving forward.

In closing, Mrs. Testa advised the BOE of her meeting in Albany as part of the New York State Commissioner's Advisory Council. She informed them she spoke on behalf of the school district and New York State on current educational topics with the Commissioner of Education and the Director of NYS Council School Superintendents and advised she will speak more to the advocacy efforts addressed once more information is available.

**CURRICULUM AND
INSTRUCTION REPORT**

Mrs. Pollitt shared highlights districtwide:

- The Bellmore Merrick component districts, consisting of all five districts, met on a zoom last week with their respective Technology staff to discuss, compare, and strategize what is done at the elementary and high school levels, and the relationship between them, i.e. STEAM, robotics, coding, etc.
- In partnership with the PTA, all five buildings contracted to participate in *Limitless Learning*, a cultural arts assembly, focusing on the power of words utilized towards an individual, and the effects words can have on a long term basis.

Mrs. Pollitt shared NYS has lifted the embargo on the NYS assessments and indicated the report cards by district will be forthcoming in Newsday. She distributed a Proficiency Percentage comparing the 2023/24 and 2024/25 school years for North Bellmore to illustrate the growth. Mrs. Pollitt discussed the importance of the data and how principals and teaching staff meet and analyze it by building, grade and cohort levels. Mrs. Pollitt proudly shared the district is on track and the data will be utilized to assess areas where improvement may be needed.

In closing, Mrs. Testa proudly shared her gratitude and recognition to the North Bellmore teachers as leaders in the classroom, inspiring academic growth, and competent and passionate learners. Mrs. Corless on behalf of the BOE reiterated Mrs. Testa's sentiments and thanked Mrs. Pollitt for the data.
